The Legacy of Peter the Great

In Ancient Greece, you could have a Will by telling seven witnesses your wishes. The Romans improved on this by requiring a Will to be written down and signed by witnesses, which of course we still practice today.

Fast-forward to the reign of Peter the Great, Czar of Russia from 1692 until 1725. Peter was an educated man who wanted to move his homeland into the modern era, which included adopting Western modes of dress, science, and the law.

Typically ruling families of this day didn't need a formal Will because their successors and heirs were obvious. However, Peter—who had fathered 14 children—only had two teenaged daughters left when he lay on his deathbed. As no female had ever ruled Imperial Russia before, an urgent decision had to be made.

At age 52, Peter had already outlived the typical male of his day by about 15 years. But a raucous lifestyle of frequent travel and celebrations combined with a serious medical illness combined to put the Czar in intense

pain during his last days. Peter asked for a pen and pad, on which he wrote "Give all to ____" and the pen fell from his hand. Peter then asked for his daughter Anna, presumably to tell her his verbal Will, but before she arrived at his bedside

he slipped into a coma and died within hours.

What an unfortunate ending to a remarkable life! No estate planning, no Will, no male heir! What would become of the Russian Empire? The decision was made quickly and in secret by a small group of Peter's supporters, who chose his wife Catherine as best to rule in her husband's stead. Catherine's short reign paved the way for numerous other females to rule Imperial Russia. What a legacy, indeed!
